

Bin Yuan Healthcare Fund SFDR status as of March 2021: Article 8

February 2024



Investment Review

The Hereford Funds – Bin Yuan Healthcare Fund (share class L1) increased 10.79% for the month of February (net of fees) compared with a 10.71% return for the benchmark. As of the end of February, the Sub Fund was mainly invested in Healthcare Equipment & Parts and Services, with few positions in the Pharmaceuticals sector.

For the month, the Fund outperformed the benchmark by 8bps. Positions that contributed most to the portfolio were IRAY TECHNOLOG, INNOVENT BIOLOGI and KANGJI MEDICAL. Positions that contributed least were WUXI BIOLOGICS, WUXI APPTEC CO and SINO BIOPHARM.

Manager's Commentary

After panic selling in January, the Chinese market made a robust recovery in February. This rebound was fueled by an uptick in investor confidence, buoyed by a series of broad-based government initiatives aimed at bolstering economic and market stability.

At the stock level, iRay Technology outperformed in February on the receding impact from previous medical anti-corruption campaigns. iRay's products are key components for medical image clarity and industrial inspection accuracy. Going forward, its products can be used more and more broadly in a variety of industries, such as medical, security checks, semiconductor chip testing, etc. The import substitution trend in the domestic market with product expansion in dental, industrial and non-detector products, and breakthroughs in overseas markets should continue to act as long-term growth drivers.

Sinopharm Group underperformed in February due to profit-taking. Sinopharm Group is a leading distributor of pharmaceuticals, healthcare products and medical devices, as well as a leading supply chain service provider in China. The company has 18% market share in China's pharmaceutical distribution and 16% market share in China's medical device distribution. Currently, Small distributors are unable to meet the new demand from hospitals, so the leading companies, such as Sinopharm Group, shall have opportunities to take market share. The company has a low valuation of 7x PE and maintains a dividend yield of 4%-5%, making it a quality underlying worth holding for the long term.

Right after the Chinese New Year, we talked with many companies in the healthcare industry. It is gratifying that many companies have exceeded their expectations for year-on-year growth in the first two months. More importantly, the domestic downstream investment willingness are recovering, which is an important leading indicator for the industry. Now, our portfolio sells on a forward PE of 17.6x (Weighted Avg. Method) and we project earnings growth of 21% over the next three years, which is very attractive for long-term investors.
