



Bin Yuan Healthcare Fund SFDR status as of March 2021: Article 8

May 2024

Investment Review

The Hereford Funds – Bin Yuan Healthcare Fund (share class L1) decreased -2.74% for the month of May(net of fees) compared with a -4.39% return for the benchmark. As of the end of May, the Sub Fund was mainly invested in Healthcare Equipment & Parts and Services, with few positions in the Pharmaceuticals sector.

For the month, the Fund outperformed the benchmark by 1.65%. Positions that contributed most to the portfolio were KANGJI MEDICAL, SHENZHEN NEW and JINXIN FERTILITY. Positions that contributed least were IRAY TECHNOLOG, AK MEDICAL HOLDI and INNOVENT BIOLOGI.

Manager's Commentary

In May, the overall healthcare segment was stabilizing. Akeso (9926.HK, one of the top Chinese biotech companies) released its so-so clinical research data, which caused fluctuations in the stock price of the entire innovative drug segment. We do not believe that this will change the development of Chinese innovative drug companies. Many companies that have already adopted a 'following' strategy and achieved success in the past are starting to build many new targets and technological capabilities, such as Innovent (1801.HK) and Beigene (6160.HK). Some traditional pharmaceutical companies are also spending increasing resources on innovative drugs in order to break through, such as Sinobiopharm (1177.HK) and Kelun (002422.SZ). We believe that China's innovative pharmaceutical companies are on a correct path to be successful.

Furthermore, what does not conflict with ongoing anti-corruption efforts is the importance placed on the entire healthcare system, including improving medical practitioners' return. In this context, private medical service providers have structural opportunities. In the early stages of development, we were very successful in finding growth opportunities for private specialized hospitals like Aier Eye Hospital (300015.SZ). Now, we believe that with the maturity of capital and market, comprehensive private hospitals have the opportunity to grow since they are more market-oriented, efficient, and transparent. We have increased our position in this field, such as Hygeia (6078.HK).
